## NEW FAMILY VISIT DOCUMENTATION

We recently made changes to our screening criteria for anyone coming onto Lexington property. We made these changes so we could stay current with the screening for the symptoms identified by the CDC and the Department of Health. Given this we have updated our tools that are used when working with families who are planning to visit with people we support. Please use these new documents for any future visits with family members so that we can be sure that they occur as safely as possible. The intended use of these documents is outlined within the COVID Guidelines: On Site Family Visits and Family Visit Guidelines – Family Home Visits. ### NEW COVID FACE SHIELD PROTOCOL

Given the increasing numbers in our counties and within our Lexington Family, we have decided to add another layer of PPE for day-to-day use across all sites when working with people we support. Effective on Friday, 12/3, staff is being asked to wear both a surgical mask and face shield whenever working with people we support. The only times the mask or shield can be removed would be if the staff member is taking a break and is more than 6 feet away from anyone else. We are committing to this new precaution for a 2-week period, after which we will re-assess and determine next steps. Please reference the document at the link below, making sure to know that the shield does not take the place of the mask - both have to be worn to be most effective. REMINDER: **Face shields should not be worn while driving.**

#### VACATION BUY BACK

Our employees have worked tirelessly this year to provide high quality supports to the people who depend on us.
