DIRECT SUPPORT SUMMER RECOGNITION PROGRAM ANNOUNCED!

WHO IS ELIGIBLE? All employees with direct support professional job titles, including: DS Aides, DSS, DSC, Residential Cook, Cook/DSS, Cook/Housekeeper, DS Specialist, Residential LPN, Assistant Manager, Weekend Support Specialist, Peer Mentors, IRA Weekend Team, Community Support DSPs, RMs, PMs.

How Do I EARN THIS RECOGNITION? All you have to do to earn the recognition is have zero unscheduled absences (call outs, late arrival, early departure) from your scheduled shifts during the recognition period. "Scheduled Shifts" include your normal work schedule and shifts you sign up for/commit to that are outside of your normal weekly schedule.

How DO I EARN THE \$600? You can earn an extra \$200 bonus for reporting to work for all of your scheduled hours during each of the three time periods of the summer recognition program: June 2-July 1, July 2-July 30, and July 31-September 9.

NEW and IMPROVED Employee Referral Bonus Program Deadline Approaching—Act by June 30, 2023.



Lexington's recently revamped employee referral bonus program pays employees a \$500 bonus for the successful referral of DSP hires, but now it can score you some great prizes, too! Details about the current referral program can be found here. Information about the employee bonus raffle prizes appears below.

If you refer a full-time or parttime DSP (who commits to at least 20 hours of work per week) with an application date between March 20 and June 30 and they are successfully hired, you will be entered into a drawing to win an Apple iPad. An Apple iPad will be awarded to one referring employee based in Albany; one based in Schoharie; and two based in Fulton County.

From the remaining entries, one employee will be selected for our Grand Prize to be drawn on Monday, July 24 to include a choice of the following: 2 nights and 2 days for four at The Great Escape Lodge, Lake George and a \$200 Visa gift card; \$500 gift card to the grocery store of your choice and a \$300 gift card to the gas station of your choice or for Uber; or a Pitboss Smoker, 2 bags of pellets and a \$150 gift card to the grocery store of your choice.

There is no limit to the number of qualified applicants an employee can refer. You will receive one raffle entry for each successful full-time or *part-time DSP hire during the time frame noted above. (*The part-time employee must commit to work at least 20 hours per week). Employees may not refer an applicant more than once. Former Lexington employees applying for re-hire beyond one-year since their separation date are considered new applicants. Referring employees listed on the new application will be eligible for the bonus/raffle prize. To qualify for the bonus, the applicant must be successfully hired. Winning employees must be in good standing at the time of the drawing. *Exclusions - Bonuses will not be paid for: Candidates hired as Family Directed Respite Aide, Human Services Intern, Self-Directed, or Per-Diem positions. Agency Executives and Human Resource Dept. staff are not eligible to participate in this program.*

401(k) Plan Document Change For your information only

There has been an amendment to the 401(k) plan effective April 1, 2023 to exclude bonuses funded through state or federal payments from compensation for purposes of employer matching and employer discretionary contributions. This amendment does not limit the employee's ability to make additional employee contributions based on these bonuses (i.e. eFMAP and Healthcare Worker Bonus Programs). This was completed by AIG as per legislation passed by NYS and NYSARC requires all Arc chapters in New York State to comply. 

Change to Cost of COVID Testing

As of May 11, 2023, CDPHP is implementing a "cost share" for COVID testing conducted at medical provider locations outside of Lexington. This means if you have a COVID test done at urgent care or at your physician's office you will incur the normal 20% co-pay for that test as you do for other tests. The change to cost sharing is due to the end of the COVID-19 Public Health Emergency Declaration by the Federal Government. However, Lexington will still continue to offer FREE COVID testing through our nursing department.
